GENERAL RULES

1. The NDQHA Futurity is open to all breeds. Owners & Exhibitors must be current members in good standing with NDQHA.
2. Judging for the Futurity will be held in conjunction with the NDQHA Legendary Labor Day Show at Valley City Winter Show Arena. All AQHA rules shall apply. Tie breaker judges will be designated before the show.
3. Date of nomination and payments will be determined by postmark. A late fee of **\$20.00 per class** will apply and be collected if nomination fee is received after August 10th, 2026.
4. No refunds or substitutions of horses will be allowed except in the case of death of horse. A letter from a veterinarian must be sent with substitution or refund request.
5. Horses nominated and subsequently sold remain eligible if the new owners are or become members of NDQHA and all sustaining payments, including late fees are paid. Owners are expected to notify the Futurity secretary of any changes.
6. All NSF checks will be charged \$35 service charge and all bank fees that are incurred. Any NSF checks will result in cancellation of the entry.
7. Entries will be placed with the combined points of the three (3) judges placing all Futurity entrants each day. Payout is based on overall points.
8. Points will be awarded according to the total number of entries in each class. The highest point total of the three (3) judges will determine the overall winner for each class.

PAYBACK SCHEDULE: All scheduled payments paid to each class (less 10% and late fees) will be paid out to entries in that class. Payments over \$600.00 are reported to the IRS. All prizes and money will be awarded at the show, to the owner of the horse. Late fees will apply after August 1st.
